## **NOTICE TO COMPETITORS**

- **SAFETY** of the dogs is our primary concern.
- **BY ENTERING THIS TRIAL**, competitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- **IT IS EXPRESSLY UNDERSTOOD** that competitors alone are responsible for the behavior of their dog(s) and / or children. Any competitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- **DUPLICATE SCRIBE SHEETS:** Bo-Gee Agility is offering competitors duplicate scribe sheets!! Be sure to pick yours up right after your run! They will be located ringside.
- **DISCIPLINARY PROBLEMS** will be reviewed by the Trial Committee, and appropriate action WILL be taken if necessary. Please keep your dog a safe distance from other dogs. Not cleaning up after yourself, your guests, and your dog(s) is a disciplinary problem. You will be dismissed from the trial if you fail to clean up!
- **FOOD:** Will be announced in your final confirmation letter.
- **KEEP DOGS LEASHED:** Please keep dogs in control and don't allow dogs to run loose. All dogs must be on leash at all times, except when using the warm-up jump and when in the ring.
- **VENDORS:** Please contact Laura Raymond in advance to reserve a vending spot. ([bo-gee@comcast.net](mailto:bo-gee@comcast.net)). A donation of \$25 per day will go directly in the Volunteer Gift Basket.

Placement ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place in each level in each class. Dogs with an "NT" (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Title rosettes will be awarded to dogs completing all legs in a specific level (CL-2, CL-3, etc.) and those dogs completing Individual Level 5 class championships & Level C extraordinary titles. Those dogs earning their C-ATCH, CS-ATCH, CT-ATCH, C-ATE, CS-ATE or CT-ATE will be awarded special rosettes and a gift.

## **DIRECTIONS TO THE TRIAL SITE**

From Route 101 take exit 3. Turn right at stop sign getting on Route 43 North. Go about 1.7 miles. The road will fork and there is a blinking light. Bear left staying on Route 43 North. Go approximately 2/10 of a mile. At the stop light go straight staying on Route 43 North. Go approximately 3.5 miles. Turn right onto Cotton Road (If you go past the main and south gate of the fairgrounds on your right, you've just past Cotton Road). The entrance we will be using is approximately ½ mile up Cotton Road on your left. Once you have passed through the chain link entrance onto the dirt road drive straight back approximately 1-1/4 miles. You can see the main fairgrounds on your left. That is not us! Follow the tree line on your right until the road bends to the left. There is a gate into the campground area, our site on your right.

### **IMPORTANT SITE INFORMATION**

**FLAGGED/ROPED OFF AREAS** are off limits to competitors. Do not move ropes without the express permission of the Chairperson. Competitors are not to rope off any areas without the express permission of the Chairperson.

**BUFFER ZONES:** CPE requires a 10' buffer zone from the ring barriers. Please respect the buffer zone by not having any food, chairs, tents, etc. in this area.

**A WARM-UP JUMP** shall be provided for all **entered** dogs. Competitors may not use the warm-up area to relieve their dogs and may not use any other equipment, personal or otherwise, for the duration of the trial, unless in the ring.

**RVs:** RVs and overnight Tents are allowed at this site and must be prepaid. Please fill out the form in this Premium. Selection of sites will be first-come, first-served. Please use caution in your selection of a Tent site. Be aware that people in RVS may be arriving AFTER dark.

**TENTS/EZ-ups:** May not be set up on the west side of the ring. That side is reserved for vendors.

**CPE trial rules – shortened version: see the online rulebook at [www.k9cpe.com](http://www.k9cpe.com) for registration info, “Registering with CPE” and further info on height categories and rules.**

**Jump Heights – no dog will jump lower than 4”**

NOTE: P-Card = Permanent Card: the lowest allowable Regular height a dog may jump in CPE.

**General CPE rules for entries/show site:**

- Dogs must be at least 15 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day Of Show entries. Registration forms are on the Forms page: [www.k9cpe.com](http://www.k9cpe.com). Forms MUST be mailed to CPE and are processed 2-3 times per week. CPE ID numbers are emailed to legible email addresses. Registrations can only be processed from mailed forms.
- Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½” of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. Exhibitors may not use the warm-up area to relieve their dogs.
- Exhibitors must verify their entry information and report any discrepancies to the show secretary by the closing or move up date for the trial. The show secretary is not obligated to make changes at the trial if it is the exhibitor’s error. No changes will be made once the trial has been completed when the handler did not report an error before or at the trial.

***Dogs in the ring, leashes, exiting the ring***

- Dogs shall run without anything attached to its body. This is for the safety of the dog. This includes no: collars, stitches, wraps or any other item. The only exception is a small barrette or rubber band to keep hair out of a dog’s eyes.
  - Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
  - Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.
- Handlers may not carry their leash with them on the course – if done so, an NT will result. Exception: Handicapped handlers that have a mobility problem in picking up the leash at the finish may put their leash in their pocket – the leash must be out of sight.
- Dogs must be under the handler’s control when leaving the ring or the judge may enter the run as No Time - NT.

***Training a dog in the ring during a run***

There is no training in the ring at a CPE agility trial. First offense will result in an excusal from the run. Further offenses will result in additional excusals for the day/weekend per the judge’s discretion. This is for the safety of the dog.

The following items *are not* considered training in the ring (also see FEO):

- Dog grabbing it’s leash at the end of a run (if the run has not yet ended, the dog would receive an NT)
- Asking the dog once for a sit or down on the table in the point games (asking more than once will be a delay of finish, 5 faults/points)

The following items *are* considered training in the ring:

- Violating the 4 paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games

***While running on course***

- The handler will direct the dog through the course without a collar or lead.
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10’ feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5 fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be, but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report would be filed with CPE. See Faults, Eliminations and Excusals.

## Times everything is happening

### Competitor Arrival Time & Measuring:

- Friday** 8:00 a.m. with Measuring at 8:00 – 8:15 a.m.  
followed by general briefing followed by first walk-through  
followed by first dog on the line.
- Sat/Sun** 6:30 a.m. with Measuring at 7:15-7:30 a.m. followed by general briefing  
followed by first walk-through  
followed by first dog on the line

**Only those handlers** with dogs requiring measurement are required to check-in.

**There will be no measuring of dogs** after Judge’s Briefing begins each day. All dogs without a permanent height card must be measured before the Judge’s briefing to show that day. There can be no exceptions because only the Judge of record for this trial is allowed to measure dogs.

**Competitors not attending the general briefing** will still be subject to the terms and conditions set forth in such a briefing. Neither the judge nor the host club is required to provide details of the general briefing once it has been given. There will be no exceptions.

- **This is a LIMITED TRIAL. Mail your entries to arrive ON the opening date.**
- **CPE DOG REGISTRATION:** A membership form is available online. Visit CPE's website at: [www.k9cpe.com](http://www.k9cpe.com). Do not send your dog registration forms with your entries. They must be sent directly to CPE. Allow enough time to snail mail your dog registration form to CPE and to receive your number before the closing date. CPE WILL NOT ACCEPT EMAILED OR FAXED REGISTRATION FORMS. THEY MUST BE MAILED.
- **ENTRY ACCEPTANCE METHOD, ENTRY CLOSING DATE, PRETRIAL MOVEUP DEADLINE:** See cover page. In addition, entries must be received by the closing date.
- **Move-ups** pretrial must be received **in writing** by e-mail to [TSS@trialsecretary.com](mailto:TSS@trialsecretary.com). The notice of the move-up must identify the Club name, date of trial, name of the dog moving up, handler, dog's CPE number, current classes and levels entered, and what classes need to be moved up one level. All move-up requests will be acknowledged. If you do not receive an acknowledgement within a day of your request, please inquire again with the trial secretary. We appreciate your moveups as soon as you can send them!
- **MOVE-UPS AT THE TRIAL:** Bo-Gee is offering move-ups at the trial in classes that are repeated. Please submit your request for a move-up within 30 minutes of scores being posted for your class. Forms for moving up will be on the ribbon table.
- **PRE-CONFIRMATIONS:** Pre-confirmations will be emailed as entries are received and processed☺. PLEASE CHECK YOUR ENTRY INFORMATION!
- **FINAL CONFIRMATIONS:** Final Confirmations will be emailed to all competitors that provide an email address within one week of the first day of this trial. PLEASE let the Trial Secretary ([TSS@trialsecretary.com](mailto:TSS@trialsecretary.com)) know if you have not received your confirmation by then.
- **ENTRY STATUS:** If you want to check the status of your entry, please visit the Trial Secretary's web site, [www.trialsecretary.com](http://www.trialsecretary.com), where the current list of competitors can be found. The list is updated periodically as entries arrive.
- **MONEY STUFF:**
  - **REFUNDS:** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee. There shall be no refunds for entries withdrawn after the closing date. However, a refund of up to 50% of entry fees for injuries to dogs or handlers, or bitches in season, may be given if the request is received in writing by the Trial Secretary ON OR BEFORE the pretrial move-up date (see cover page). The request MUST be in writing and MUST be accompanied by a dated letter from your Veterinarian (or Doctor, if the injury is to the handler) on your Veterinarian's (or Doctor's) letterhead with a brief description explaining the reason the dog, or the handler, cannot compete. Also, no entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
  - **BAD CHECKS:** Any bad check, for any reason, incurs a \$30.00 charge, in addition to bank charges. BAD CHECKS are defined as any check that does NOT clear TSS's bank the FIRST time it is deposited. All entry fees will be deposited immediately following the closing date. Please plan accordingly.
  - **FOREIGN COMPETITORS/CHECKS:** Fees must be submitted in United States Funds. If the check is written on a Canadian bank, NOT payable through a United States bank, or is a Canadian Postal Money Order, include a \$10 fee with your entries.
  - **OVERPAYMENTS** of entry fees will not be refunded. PLEASE CHECK YOUR MATH.
  - **UNDERPAYMENTS** of entry fees do not constitute a valid entry. PLEASE CHECK YOUR MATH.
- **ENTRIES:** The first attempt at resolving an issue on an entry form will be made by email. If no response is received by the competitor within a reasonable amount of time, the Trial Secretary will telephone.
